RAMON LAPERRA STATEMENT

SEPT 13/95 - watched 10 natives, some with rakes combing sand where ^{I later learned} Dudley George was shot.

Saw 5 to natives digging ^{R.I.E.} something out of posts, trees and A frame shacks that would have been behind ~~the~~ OFF TRU (Tactical Response ~~Team~~) ^{unit} 5 CAU (Crowd Mgmt Unit) on the night George was shot.

AUG 95 - Driven North on Hwy 21 past base. Saw brown van pull up to Dudley George's trailer (near fence) and five natives got out with rifles. One was George who had a rifle with a scope. Knew George well - was short, handlebar mustache, always wore folded bandana as ^{cap}

a sweat band, never covering his head, always wore sunglasses. The men went into the George trailer.

Earlier in the month shots were fired near La Bosanquet town work crew by natives firing from a brown van on the occupied former CFB Upperwash, according to news reports.

I HAD RIFLES AND A CROSSBOW POINTED AT ME BY NATIVES.

(2X) RIFLE: IN FRONT OF HOUSE WE OWNED ON BEACH

CROSSBOW: ON BEACH, APPROX 1000' FROM OUR HOUSE. I WAS IN MY CAR, THEY WERE STANDING BY THEIR CAR.

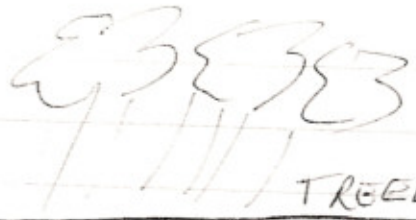
